## REGULAR MEETING

The Village of Gratiot Board held a meeting on August 6, 2019 at the Village Hall at 6:00 PM.

Village Board members present were Gary Signer and Drew McGlynn. Board member Kara Stietz was absent. Also present were Travis Signer, Brian Sigafus, Ramona Wehinger, JR Kingery, and Lucas Stietz. The meeting was called to order by President Gary Signer.

The meeting was posted in the Village at Village Hall, the bank, the post office, and the fire station.

Motion by McGlynn, Second by G. Signer, to approve the agenda as presented. Motion carried.

Motion by McGlynn, Second by G. Signer, to approve the minutes from the regular meeting on 07/09/19. Motion carried.

## PUBLIC COMMENT-

Ramona Wehinger was present to ask about the following:

- What is the Village Patrolman's expected hours of work? The Village Patrolman is hired on an annual salary, with the expectation of working a minimum of 40 hours per week.
- Why is the Patrolman salary higher than the past Patrolman? The current Patrolman has 17 years of experience in public works.
- When will hydrants be flushed? Hydrants will be flushed soon and a notice will be provided.
- Will the Village Patrolman do small skid steer work for Village residents if time allows? Yes.

JR Kingery was present to tell the board that Green County EMS is requesting street signs be placed at the intersections of Main, Sheldon, and Noble streets, where they intersect Highway 11.
