The agendas for the 2021 Caucus and January 5, 2021 regular meeting are attached. Please see below for comments regarding agenda items and other business.

CAUCUS AT 5:30. Gary and Kara's seats are up. We will need people there to nominate and second them.

Crime Policy: Our insurance agent reached out to me regarding having a crime policy for the Village. This would cover Employee Dishonesty, Computer Fraud/Theft, and Transfer Fraud. He thinks it would cost between \$475 - \$550 per year for \$100,000 per loss coverage.

Clerk Expenses – My mileage reimbursement for 2020 is attached. It is very low.

ATV Ordinance: We had the first reading of the ATV/UTV Ordinance last month. It can now be read a 2nd and 3rd times at this meeting. If there are no objections to the readings, you can vote to have me post the ordinance and bring it up for final approval in February.

2021 Election Relier Services: The County is charging \$700.00 for relier services this year. This includes updating poll books, voter registration with the state, sending me election forms, updating absentee ballot info, etc.

Public Hearing Date: We need to hold a public hearing for the Main Street Grants. Bart's office is doing most of the legwork on this, with help from me. The hearing needs to be set for 1/20/21 at 6:00 PM.

Web Admin Pay: It is the time of year to discuss what we get Laurie A. for web services throughout the year.

Voicemail: Jan would like voicemail in the library. I think this can either be done through the CenturyLink account, or by purchasing an external voicemail machine. I have not priced either.

Office Flooring: Gary wanted this on the agenda.

Dumbbells: One of the fitness center members asked if we could purchase a few heavier dumbbells (40-50#). I put a quote in the packet for you.

Driveway Plowing- Gary wanted this on the agenda.
